James Boyd White is the L. Hart Wright Collegiate Professor of Law (Emeritus) and a Professor of English (Emeritus) at the University of Michigan. He is a member of the American Law Institute and the American Academy of Arts and Sciences and is also a former Chair of the Michigan Society of Fellows. Professor White writes on law and literature, law and religion, the social sciences, torture, democratic theory and law and culture. Among his many books are *Heracles' Bow: Essays in the Rhetoric and Poetics of the Law (1985), Acts of Hope: The Creation of Authority in Literature, Law, and Politics (1994), and Living Speech: Resisting the Empire of Force (2006).* He holds a J.D. and an M.A. from Harvard.
