The David Berg Institute for Law and History at Tel Aviv University Year 3 Annual Report for 2011-2012

We are delighted to submit the progress report for the third year of the David Berg Institute for Law and History.

The Institute's activity continued and increased. It organized or supported seven international and local conferences and events, including the 3rd Berg Conference, which was a great success. It supported research projects of a number of graduate students and faculty, and also enabled several key academic activities related to legal history including the TAU law and history workshop and the annual meeting of the Israeli History and Law Association. We are now working on several conferences and other events planned for next year, with the continued support of the Berg Foundation, for which we are, of course, extremely grateful.

CONFERENCES, LECTURES AND SYMPOSIA

1. 3rd Berg International Conference: "The Declaration of Independence Revisited" December 11-12, 2011 | See Appendix A

This was the third international conference organized by the David Berg Institute for Law and History. It was the first attempt to dedicate a whole conference to Israel's Declaration of Independence. Among the participants were internationally renowned researchers, five Israel Prize recipients, legal scholars, historians, philosophers and artists.

Among the topics discussed were the tensions embodied and reflected in the Declaration: the international justification versus the historical one, the Jewish nature versus the democratic nature of the State of Israel, the Zionist and the Jewish narratives as fundamental justifications for the establishment of Israel, American influences versus local attempts to influence the wording of the Declaration, the role of legal scholars and diplomats in the drafting process, its place in Israel's collective memory and its legal and political status in the public sphere.

 Transition from the Jewish Yishuv in Mandate Palestine to an Independent State September 21, 2011 | See Appendix B

Israel's political, social and economic historians have often been unaware of the possible contribution of legal history to the study of the general history of the Jewish *Yishuv* and the State of Israel. This was the first attempt to bring Israel's general and legal historians together to discuss the transition that occurred in 1948 from a Jewish community to a Jewish state. In exposing general historians to the work done by legal historians on this topic, the conference highlighted the possible contribution that legal history can make.

The conference included four sessions. In three sessions, two legal historians presented papers on constitutional history, economic and cultural history and issues related to land and labor. A chair and commentator who are not legal historians worked to create a dialogue between the legal and non-legal historians. The final session was a roundtable panel on the possible contribution of legal history to the general history of Israel.

Participants included leading political, social and economic historians of Israel and the doyen of Israeli historians, Prof. Anita Shapira, as well as Profs. Yechiam Weitz, Jacob Metzer, Zeev Tzahor, and Yoav Gelber.

The conference took place at the Tel Aviv University Faculty of Humanities and attracted Israeli historians, graduate students and the general public. A follow-up conference is planned for next year on the political, economic, social and legal history of the Israeli welfare state.

Qing to China: Rethinking the Interplay of Tradition and Modernity, 1860-1949

This international conference was organized by the Tel Aviv University Department of East Asian Studies and presented cutting-edge research on late 19th and early 20th century Chinese history. The Berg Institute was one of the sponsors of the conference, and provided funding for a panel devoted to Chinese legal history.

Our panel included papers by two Chinese-American historians from Princeton and Columbia on the history of vagrancy, immigration and intellectual property law. It was chaired by David Berg Institute Director Assaf Likhovski; Prof. Madeleine Zelin of Columbia University, one of the world's leading economic and legal historians of China, served as commentator.

Marc Galanter, a Professor of Law and South Asian Studies at the University of Wisconsin and the London School of Economics and Political Science, is a leading figure in the study of law and society. He is also the foremost American scholar of the Indian legal system and its history. His book, *Law and Society in Modern India*, is an influential survey of Indian legal history and Indian legal sociology. The Berg Institute, in conjunction with the Cegla Center for Interdisciplinary Research of the Law, sponsored two lectures on Indian legal history and legal sociology by Prof. Galanter.

5. Book Symposium: Moshe Landau, Judge

Justice Moshe Landau was one of the founding fathers of the Israeli judicial system, presiding over the Eichmann Trial and many other landmark cases in the 1950s, 60s and 70s. Dr. Michal Shaked's new biography of Justice Landau, published in May 2012, is one of the first judicial biographies of an Israeli Supreme Court judge.

The symposium included four lectures: two by members of the Israeli Supreme Court—former Chief Justice Dorit Beinisch and current Deputy Chief Justice, Miriam Naor; and two by Tel Aviv University legal historians Leora Bilsky and Menachem Mautner.

The audience included current Israeli Chief Justice Asher Grunis, former Chief Justice Aharon Barak, many current and retired Supreme Court justices and a large contingency of students, professors and the general public.

The Berg Institute is funding the Forum workshop on the role of Holocaust restitution in advancing the history and memory of the Holocaust. The workshop will serve as a preliminary meeting to prepare a conference on the subject planned for December 2012.

RESEARCH INFRASTRUCTURE

- Israeli Legal History Database This year saw the completion and release for public
 use of a searchable and updatable bibliographical database on the Institute's
 website. The database contains some 200 books, book chapters, articles and reviews
 in Hebrew and English regarding Israeli legal history. It is part of the research
 infrastructure developed by the David Berg Institute for the use of historians,
 lawyers and students doing research on Israeli legal history topics.
- 2. Preparations for the Creation of a Legal History Archive A public steering committee of the proposed legal history archive convened for the first time in Summer 2011; the committee includes two retired Supreme Court Chief Justices as well as senior members of the Israeli bar, the former State Archivist, historians and law professors. The committee developed general guidelines for the project, and following the meeting, negotiations started with the families of leading Israeli lawyers to obtain their personal archives. These negotiations are still in their preliminary stages.
- Research Grants to Students and Scholars The Institute provided research grants to three graduate students and three faculty members for conducting archival and other relevant research in the field of legal history.

The Graduate Students with research grants are: Yael Broida who studies the role of women's organizations in legislation during the first three decades of the State of Israel; Rivka Brot who studies the trials of Jews accused of collaborating with the Nazis in the displaced persons camps of Israel; and Aviram Shahal who studies constitution proposals during the period of the British Mandate and the early years of Israel.

The faculty members with research grants are: David Schorr who writes about water laws during the British Mandate and the first years of the state; Shai Wozner who writes about legal thought in Lithuania's Jewish communities; and Orit Rozin who writes about the struggles for civil rights in 1950s Israel.

OTHER ACTIVITIES

 The Yigal Arnon Law & History Workshop, with support from the David Berg Institute, convened regularly during the Spring 2012 term, with students and faculty joining with legal historians from across Israel and overseas to present and discuss works in progress.

Tel Aviv University Yigal Arnon Law and History Workshop

The Tel Aviv University Yigal Arnon Law and History Workshop, established in 1997, was the first workshop of its kind in Israel (the Hebrew University followed Tel Aviv's lead and established a similar workshop in 2008). The workshop, which is named after Advocate Yigal Arnon, is designed to serve as a forum in which legal historians can present works in progress. It provides a unique institutional forum for the whole legal-history community in Israel. The workshop is the place where all Israeli legal historians (both faculty members and senior graduate students), working in law schools, history departments and social science faculties, meet, present works in progress and interact with foreign colleagues. The workshop also provides TAU students with the opportunity to read and comment on state-of-the-art legal history articles, serving as the capstone of TAU's exceptional legal history curriculum. This curriculum provides students with special in-depth training in legal history and includes preliminary courses, elective courses and seminars and the workshop.

The workshop's scope is not limited temporally, geographically or methodologically. Papers presented deal with all periods (ancient, medieval and modern) and all geographical areas (Israel but also the United States, Britain, the continental and Islamic law worlds). The workshop also seeks to present a broad variety of disciplinary approaches to legal history and including economics, anthropology, sociology and cultural studies.

Over the years, the workshop has spawned a number of important institutional and academic projects related to legal history including several Israeli and international academic conferences, special journal issues on legal history and the creation of a nation-wide Israeli legal history association.

A wide range of scholars including some of the world's leading legal historians have given papers at the workshop.
